

## ARE YOU THINKING ABOUT MOVING TO THE UK?

The UK's new British National (Overseas) Visa permits Hong Kong citizens with BNO status to come to the UK with their close family members for five years. After five years of residence in the UK, they will be entitled to apply for settlement – termed 'indefinite leave to remain' – and after one further year of residence to apply for British citizenship. BNO Visa holders are able to work or study freely in the UK and there is no limit on the number of eligible people who can come to the UK.

Any BNO citizens in Hong Kong who are looking to relocate or invest in the UK will need to ensure that they have a clear understanding of the UK tax system and should make pre-arrival tax planning a priority. UK income tax rates of up to 45% are generally much higher than those in Hong Kong, while the UK also levies tax on capital gains and inheritance.

The UK tax code provides a preferential tax regime for those who are resident but not domiciled in the UK ('Non-Doms'). Although considerable changes have been made to the rules in recent years, it still remains a very attractive regime for non-UK domiciled individuals coming to live in the UK.

Moving to the UK can be a daunting process for you and your family – even more so if you run your own business. In addition to the logistical, financial and emotional pressures, there are a number of practical issues that will also need to be addressed: location, accommodation, security, business set-up, employment, banking, registrations, documentation, insurance and access to healthcare or education.
